What follows is an explanation of the forms that are needed to do an adoption and how our service works with simple directions for getting started. Please remember that EVERY ADOPTION IS DIFFERENT, also that EVERY STATE AND COUNTY IS DIFFERENT. Therefore, it is practically impossible to buy a regular adoption kit and expect to have ALL the forms and information you would need. It would take a service that works one on one with a customer (you) to do an adoption well. That is what we offer you, the ability to do your own low cost adoption.

We provide you with secretarial services to do your own low cost adoption through the mail, or E-mail. Thereby, eliminating the need for the high costs of lawyers. Any individual wishing to start an adoption must file the correct adoption papers with local county court according to specific rules. If you talk to people at the court's clerks office they may advise you to have an attorney. The clerk will tell you that they cannot give you legal information. However, you can do your own uncontested adoption, if you can read English, and follow simple instructions. Most people can make intelligent decisions once they know their options.

There are certain papers to be filed with the court to begin an adoption.

1. The Petition for Adoption (or equivalent form)
2. The Summons
3. And various other papers based on the particular situations of the Individuals. (Explained below)

Residency Requirement:

Usually, a person must live in a State 6 months or 1 year to be able to file an adoption there

Different States have different amounts of time that you must be in the State for you to get an adoption there. Also various counties have different amounts of time as well. Usually, a person must live in a State 6 months or 1 year to be able to file an adoption there. These Residency Requirements vary between State to State so, call your County Court to find out the residency requirement for your State.

The Waiting Period:

There is a waiting period in most states. The waiting period is from when you first file your adoption forms at your local county courthouse and when the Judge will see you to finalize your adoption. For example, Michigan has a waiting period for all adoptions; it is between 4-6 Months. Call your Circuit Court to find out the waiting period for your state and county.

Court Hearing and Testimony:

With uncontested or Agreed adoptions there is a much better chance of keeping a simple case simple.

After the other party has been "Served" with the adoption papers, and proof of that filing is given to the court, you can set your court date for your final hearing. You have only one court hearing in an uncontested adoption; which usually lasts around 8-15 minutes at the max. We also include in our service a FREE "Sample Testimony" sheet that will help you with what to say when you are in the courtroom. It is

Steps for an Adoption:

Time: Approximately 4-6 Months (See Waiting Period Above)

1. Get the Questionnaire and pay for our service. (Pricing below)
2. Fill out and complete your Adoption Questionnaire and Return it to us.
3. In about 2-3 business days you will be sent the correct papers for you to file to open your case.
4. File the Petition for Adoption, and any other forms that you need in your own action, with your local county court. We will show you how to find out where to go.
5. All parties are served. Proof is filed with the court. (This step is skipped if all parties are in agreement to the adoption.)



6. Final hearing date set and Notice of that hearing is given to all parties.
7. All parties are mailed all copies of papers filed with the court and proof of mailing is filed with the court.
8. Go to your final hearing and read the FREE Sample Testimony that we provide you. (You would fill in the blanks of the sample testimony with your specific information. It is a "Sample Testimony", so that we don't give you legal advice.)

If you move, you must be able to come back to go to the court for your final hearing.

The above are just outlines of an adoption. Every case may be different. It is very important, that you stay in close touch with us. Keep in close contact if you move, have your phone number changed, etc. If you move, you must be able to come back to go to the court for your final hearing.

Court Costs:

Please Note: The court costs are NOT included in our service. This fee pays the Judge and the Clerks. It is paid when you file at the courthouse. They usually accept money orders and bank certified checks. You can check with the Circuit Court in your county for the type of payment they accept.

As part of our service, we will guide you through each step in your adoption, provide you with a Sample Testimony to read in court, and give you written information on how to best prepare yourself to testify at your hearing. Most hearings only last around 8-15 minutes.

Every adoption begins with a Plaintiff (you) filing a Petition for Adoption; which asks the court to grant an order of Adoption.

The Summons is a document that legally asks the person summoned to answer the Petition. This must be delivered to that person in a way that gave them notice of the action against them. This is called "Service".

If the parties "Agree" to the Adoption then, the Summons won't be used. Instead there will be an Adoption Agreement signed by all parties involved and filed with the court.

WARNING: If one of the parties hires a lawyer to contest this adoption, MyAdoptionForms.com cannot be your personal secretary. Obviously, since "contested adoptions" are handled by lawyers.

HOWEVER: If one of the parties does hire an attorney, we do offer a service that helps you to save 25% on your legal fees. It is called the PrePaid Legal Service. Mention it to us if this is the service that you might need.
